ARTICLES OF INCORPORATION OF BURTON INSURANCE SERVICES, INC.

Article I

Name. The name of this Corporation is BURTON INSURANCE SERVICES, INC.

Article II

<u>Principal Office.</u> The principal place of business and mailing address of this corporation shall be: 650 Fountainhead Lane, Naples, Florida 34103.

Article III

<u>Duration</u>. The period of duration of this Corporation shall be perpetual.

Article IV

<u>Purpose</u>.
