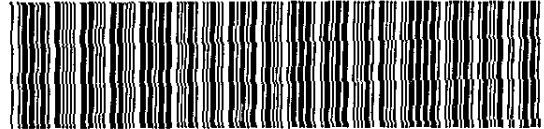

**ARTICLES OF INCORPORATION
OF

Article I

Name. The name of this Corporation is **BURTON INSURANCE SERVICES, INC.**

Article II

Principal Office. The principal place of business and mailing address of this corporation shall be: 650 Fountainhead Lane, Naples, Florida 34103.

Article III

Duration. The period of duration of this Corporation shall be perpetual.

Article IV

Purpose. The purpose of this Corporation is to engage in any activities or businesses permitted under the laws of the United States and under the Florida General Corporation Act including the acquisition of life insurance bonds, debentures, commodities, leaseholds, options, puts and calls, easements, mortgages, properties, notes, mutual funds, investment trusts, common trust funds, voting trust certificates, and any class of stock or right to subscribe for stock, including trading on margin.

Article V

Capital Stock. This Corporation is authorized to issue 100 shares of One Dollar (\$1.00) par value common stock. All shareholders shall have preemptive rights in future stock sales by the Corporation.

Article VI

By-Laws. The power to adopt, alter, amend or repeal By-Laws shall be vested in the Board of Directors and Shareholders.

Article VII

Initial Registered Office and Agent. The street address of the initial registered office of this Corporation is 650 Fountainhead Lane, Naples, Florida 34103, and the name of the initial registered agent of this Corporation is Kathleen Derum Burton.

Article VIII

Initial Board of Directors. The Corporation shall have one (1) Director initially. The number of Directors may either be increased or diminished from time to time by the By-Laws,

but it shall never be less than one. The name and address of the initial Director of this Corporation is Kathleen Derum Burton, 650 Fountainhead Lane, Naples, Florida 34103.

Article IX

Incorporator. The name and address of the person signing these Articles is Kathleen Derum Burton, 650 Fountainhead Lane, Naples, Florida 34103.

Article X

Indemnification. The Corporation shall indemnify its directors, officers, and agents against liabilities arising out of their respective services and duties to the Corporation. Indemnification will be made for costs and expenses, including attorney fees, judgments, and settlement payments.

Having been named as registered agent and to accept service of process for the above stated corporation at the place designated in this certificate, I hereby accept the appointment as registered agent and agree to act in this capacity. I further agree to comply with the provisions of all statutes relating to the proper and complete performance of my duties, and I am familiar with and accept the obligations of my position as registered agent.
