### ARTICLE VII - EXEMPT PURPOSE

This Corporation is organized and operated exclusively for charitable purposes within the meaning Section 501(c)(3) of the Internal Revenue Code.

### ARTICLE VIII - DISSOLUTION AND WIND UP
