
ARTICLE THIRTEEN

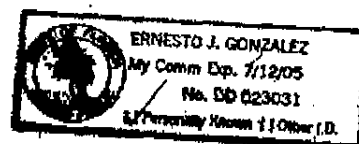
