ARTICLES OF INCORPORATION FOR ELVIRA TOKAS, INC.

The undersigned subscribers hereby associate themselves together to form a corporation for profit under the laws of the STATE OF FLORDIA: and hereby adopt the following ARTICLES OF INCORPORATION.

ARTICLE I NAME

The name of this Corporation shall be: ELVIRA TOKAS, INC. and its business shall be carried on in BROWARD COUNTY, FLORIDA, and also within and without the STATE OF FLORDIA, and UNITED STATES OF AMERCIA and FOREIGN COUNTRIES as may from time to time be deemed desirable or expedient.

<u>ARTICLE II</u> <u>TERM OF EXISTENCE</u>

This Corporation shall have perpetual existence unless dissolved by action of law or by vote of the stockholders, and shall commence business as of the date of filing these Articles of Incorporation.

ARTICLE III NATURE OF BUSINESS

The specific nature of the business to be transacted by this Corporation and the objects and purposes thereof are as follows:
