The undersigned subscribers to these Articles of Incorporation, a natural person competent to contract, hereby Brms a corporation under the laws of the State of Florida, effective APRIL 01, 2004.

ARTICLE I

- 5. To contract debts and borrow money, issue and sell or pledge bonds, debentures, notes and other evidences of indebtedness, and to execute such mortgages, transfers of corporate indebtedness as required.
