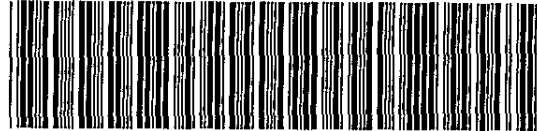



ARTICLES OF INCORPORATION
OF

SECRETARY OF STATE

RUGGERI REALTY AND DEVELOPMENT, INC.

The undersigned subscribes to these Articles of Incorporation, natural persons competent to contract, form this corporation under the Laws of the State of Florida.

ARTICLE I

NAME

The name of this corporation is Ruggeri Realty and Development, Inc.

ARTICLE II

NATURE OF BUSINESS

The general nature of business to be transacted by this corporation is that this corporation may engage in any activity or business permitted under the Laws of the United States and of the State of Florida, except that this corporation shall not conduct a banking, safe deposit, trust, insurance, surety, express, railroad, canal, telephone, cemetery company, fraternal benefit society, state fair exposition company, or engineering company.

ARTICLE III

SHARES OF STOCK

The maximum number of shares of stock that this corporation is authorized to have outstanding at

any one time is ONE HUNDRED (100) shares of common stock of the par value of ONE

DOLLAR and no/100 Dollars (\$1.00) per share only, making the total authorized capital stock of

this corporation ONE HUNDRED DOLLARS and no/100 Dollars (\$100.00). The holders of the

common stock shall be entitled to one (1) vote for each such share of common stock so held and shall participate in the meetings of the stockholders. All or any part of said common stock may be paid in cash or in property, labor, or services, the value thereof to be fixed and determined by the shareholders at their first meeting or at any subsequent meeting.

INITIAL CAPITAL

The amount of capital which this corporation shall begin business with is ONE HUNDRED DOLLARS and no/100 (\$100.00).

ARTICLE V

TERM OF EXISTENCE

This corporation is to exist perpetually.
