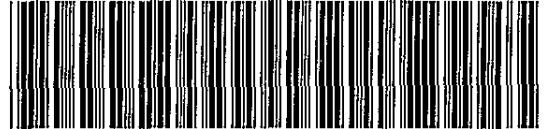

ARTICLE I

NAME

The name of the corporation is David W. Bell, Inc.

ARTICLE II

DURATION

The duration of this corporation is perpetual, unless dissolved according to Florida law.

ARTICLE III

GENERAL PURPOSES

The general purposes for which this corporation is initially organized are to engage in any or all lawful business for which corporations may be incorporated under Florida law.

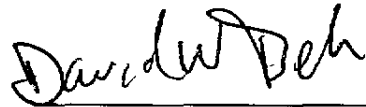
