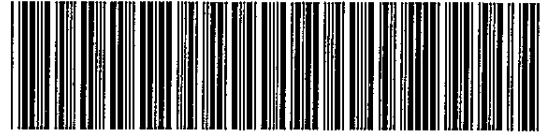



OF

ARTICLE I. NAME

The name of this corporation is
COLEY DEVELOPMENT, INC.

This corporation shall have perpetual existence.






