ARTICLES OF INCORPORATION

The undersigned subscriber, a natural person competent to contract for the purpose of forming a corporation under the laws of the State of Florida, adopts the following Articles of Incorporation for such corporation.

ARTICLE I

The name of this corporation shall be, On The Move Tours and More, Inc.

Its principal office shall be at 1327 SW Macedo Blvd, Port Saint Lucie, Florida 34983 or at such other place as may be designated, from time to time, by the Board of Directors.

ARTICLE II

The general nature of the business and the object and purpose for which the corporation is organized is to operate a business which will conduct travel tours and shall include the transaction of any and all lawful business for which corporations may be incorporated under the laws of the State of Florida.
