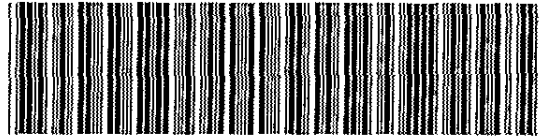

ARTICLES OF INCORPORATION  
OF

THE UNDERSIGNED, FOR THE PURPOSE OF FORMING A

HEREBY ADOPT THE FOLLOWING ARTICLES OF INCORPORATION:

ARTICLE I

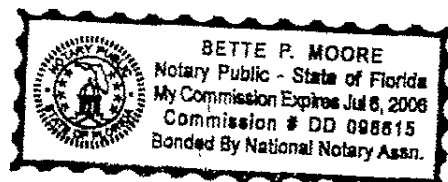
