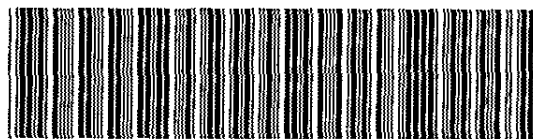

of


