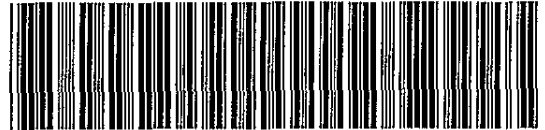

**ARTICLES OF INCORPORATION

The undersigned, for the purpose of forming a Corporation under the Florida General Corporation Act hereby files the following Articles of Incorporation pursuant to Section 607.0202 Florida Statutes concerning for profit corporations.

**ARTICLE I
NAME**

The name of the Corporation shall be **NICOLE COTTRELL CLEANING SERVICE, INC.** approved by the board of directors. The principal place of business shall be 6300 Bear Lake Terrace, Apopka, Florida 32712.

**ARTICLE II
TERM**

The term of existence of the Corporation shall begin on the day of filing, and shall continue into perpetuity, or until dissolved in a manner provided by law or by regulations adopted by the Board of Directors.

**ARTICLE III
PURPOSE**

The purposes for which the Corporation is organized is to clean residential and large businesses and all other services necessary to carry out the functions of the Corporation, to engage in any activities and to transact any and all lawful business for which the Corporation may be incorporated under the Florida for Profit Corporation Act and/or permitted under laws of the United States, doing business as **NICOLE COTTRELL CLEANING SERVICE, INC.**

**ARTICLE IV
COMMON STOCK**

There shall be 1500 shares of common stock.

**ARTICLE V
REGISTERED AGENT**

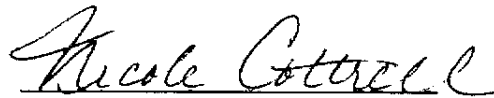
**ARTICLE IX

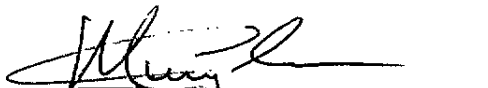
**ARTICLE X
TERMINATION**

Once terminated as a board member or an officer, the member's right to participate in executive meetings is void, unless invited by majority vote. Officers work at the pleasure of the board. A simple majority vote of the board is required to remove an officer. There will be one class of members.
