**BE IT RESOLVED** that Article I of the Articles of Incorporation is amended as follows:

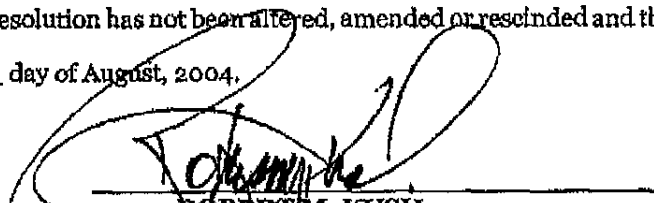
**"ARTICLE I. NAME**

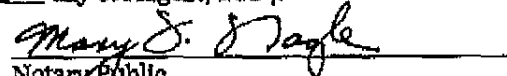
