*Pursuant to the provisions of Section 607.1006, Florida Statutes, this Florida profit corporation adopts the following articles of amendment to its articles of incorporation:*

**FIRST:** The date of filing of the Articles of Incorporation was April 7, 2004.

**SECOND:** The following amendments to the Articles of Incorporation was adopted by the corporation:

**Article I: Corporate Name and Principal Office**

**Article III: Purpose and Powers**
