ARTICLES OF INCORPORATION OF FIDELITY FIRE & CASUALTY COMPANY

The undersigned incorporators to these Articles of Incorporation, natural persons over the age of 18 years, competent to contract and all of whom are citizens of the United States of America, hereby form a stock insurance corporation in accordance with Chapter 628, Florida Statutes, and the pertinent provisions of the Florida Insurance Code.

ARTICLE I. NAME

The name of the corporation shall be: FIDELITY FIRE & CASUALTY COMPANY. The principal place of business of the corporation shall be 200 Colonial Center Parkway, Suite 100, Lake Mary, County of Seminole, State of Florida 32746.

ARTICLE II. NATURE OF BUSINESS

The purpose of the corporation is to engage in the business of insurance as a domestic stock property and casualty insurance corporation and to conduct such other business as permitted under the laws of the State of Florida.
