




All actions taken by the officers and directors since the commencement of the corporation in 2004 are hereby approved and ratified.

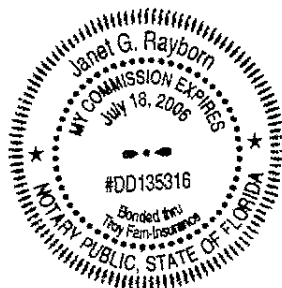


