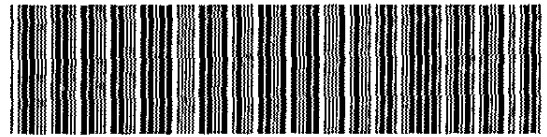

ARTICLE V DIRECTORS






