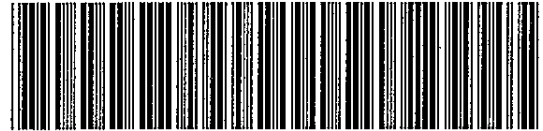

The undersigned incorporation, being of full age, does hereby make and file the Articles of Incorporation under the provisions of the Florida General Corporation Act for the purpose of becoming a corporation and does hereby accept all rights, privileges and obligations conferred and imposed by the laws of the State of Florida.

**ARTICLE I-NAME**

The name of this corporation is **J W MANAGEMENT GROUP, INC.**  
with it principal address at 2304 Bottega Lane, Unit 303, Brandon, Florida 33511.

**ARTICLE II-DURATION**

This corporation shall have a perpetual existence unless voluntarily dissolved according to law.

**ARTICLE III-PURPOSE**

The purpose of the corporation is to transact lawful business in the State of Florida.

**ARTICLE IV- CAPITAL STOCK**

This corporation is authorized to issue 7,500 shares of One Dollar (\$1.00) par value common stock which shall be designated "Common Shares".

#### **ARTICLE VI-PREEMPTIVE RIGHTS**

#### **ARTICLE VII-BYLAWS**

The power to adopt, alter, amend or repeal Bylaws shall be vested in the Board of Directors.
