

The undersigned subscribers to these Articles of Incorporation, hereby execute these Articles of Incorporation to form a corporation under the laws of the State of Florida.

I. NAME AND ADDRESS

II. TERM OF EXISTENCE

This corporation is to exist perpetually.


VI. DIRECTORS




