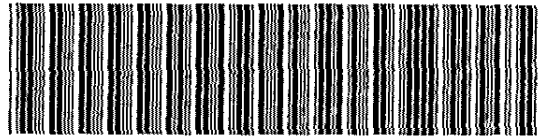

ARTICLE V



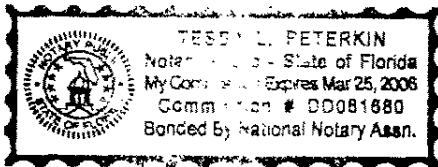


