The undersigned, acting as Incorporator of this Corporation pursuant to Chapter 607 of LORIDA the Florida Statutes, hereby forms a corporation for profit under the laws of the State of Florida.

ARTICLE I-NAME

The name of the corporation shall be Robert Rister Framing, Incorporated.

ARTICLE II-PRINCIPAL OFFICE
