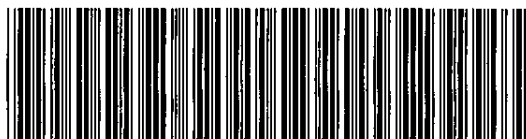

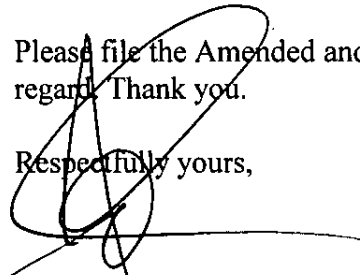

**Article I.** The name of the corporation is: Acadia International, Inc.

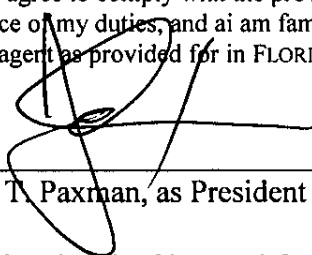
**Article II.** The corporation is authorized to transact any and all lawful business as provided by Florida law.

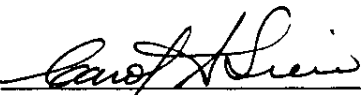

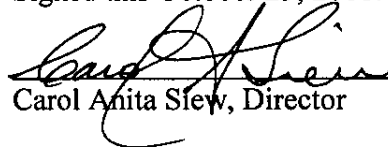

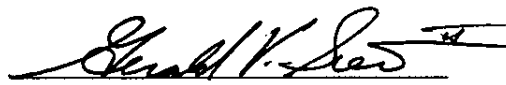
*Pursuant to provisions of section 607.1006, Florida Statutes, this Florida profit corporation adopts the following articles of amendment to its articles of incorporation:*
