The undersigned subscriber of these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

**ARTICLE I**

**Name**

The name of this Corporation is **NAILIZE DELRAY, INC.**

**ARTICLE II**

**Nature of Business**

The general nature of the business to be transacted by this corporation is nail cosmetology and any other lawful business.

**ARTICLE III**

**Share of Stock**

The total number of shares of stock which the corporation shall have the authority to issue is One Thousand (1,000) Shares, all of which shares shall have a par value of One Dollar (\$1.00) and shall have equal rights, privileges and voting power, unless other wise agreed upon.

The shares of stock in this corporation may be paid for by property, labor, or services at a just valuation, to be fixed by the Board of Directors. ### Indemnification



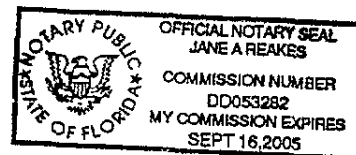
