

ARTICLES OF INCORPORATION

The undersigned, for the purpose of forming a corporation for profit under the laws of the State of Florida, hereby adopts the following Articles of Incorporation:

ARTICLE I

**Name, Location and
Mailing Address of Principal Office**

The name of the corporation is SAMUEL C. BUNTING, P.A. The principal office and mailing address of this corporation is 11763 Ft. Caroline Road, Jacksonville, Florida 32225.

ARTICLE II
Purpose

This corporation is organized for the following purposes:

1. To engage in the practice of real estate marketing, sales and property management as a professional real estate corporation; and
2. To carry on services incident to the practice of real estate sales, marketing and property management. The practice of real estate sales, marketing and property management is the sole and exclusive service to be rendered by this corporation.

The professional services of this corporation shall be carried out only through officers, employees, and agents, each of whom has been duly authorized and licensed to engage in real estate sales, marketing and property management in the State of Florida.

ARTICLE III
Capital Stock

This corporation is authorized to issue only one class of stock. The corporation is authorized to issue five hundred (500) shares of capital stock, of which five hundred (500) shares shall be issued to Samuel C. Bunting, each share having a par value of \$1.00.

ARTICLE IV
Initial Registered Office and Agent

The street address of the initial registered office of this corporation is 11763 Ft. Caroline Road, Jacksonville, Florida 32225, and the name of the initial registered agent of the corporation at that address is Samuel C. Bunting.

ARTICLE V
Directors

This corporation shall initially have one director. The number of directors may be increased or decreased from time to time but shall never be fewer than one nor more than five. The name, street address and title of the members(s) of the first Board of Directors of the corporation are:

ARTICLE VI
Incorporator

The name and street address of the incorporator of this corporation are Samuel C. Bunting, 11763 Ft. Caroline Road, Jacksonville, Florida 32225.

ARTICLE VII
By-Laws

The initial By-Laws of this corporation shall be adopted by the director(s). By-Laws may be adopted, amended or repealed in the manner provided in the By-Laws by either the shareholders or the directors.

ARTICLE VIII
Restrictions on Transfer of Stock

The shareholders may, by By-Law provision or by shareholders' agreement recorded in the minutes book, impose such restrictions on the sale, transfer or encumbrance of the stock of this corporation as they may see fit.

ARTICLE IX
Director Compensation

The Board of Directors is hereby specifically authorized to make provision for reasonable compensation to its members for their services as directors, and to fix the basis and conditions upon which such compensation shall be paid. Any directors of the corporation may also serve the corporation in any other capacity and receive compensation in any form.

ARTICLE X
Indemnification

The Board of Directors is hereby specifically authorized to make provision for indemnification of directors, officers, employees and agents to the full extent permitted by law.

ARTICLE XI
Dissolution

This corporation may be dissolved prior to the time fixed in these Articles of Incorporation by the unanimous vote of the stockholders then holding fifty-one percent (51%) voting capital stock at a meeting of the stockholders called for that purpose, in the manner, not inconsistent with Florida law, set forth in the bylaws, if any. In the event of such dissolution, the affairs of the corporation shall be wound up in the manner provided by the Florida General Corporation Act.


