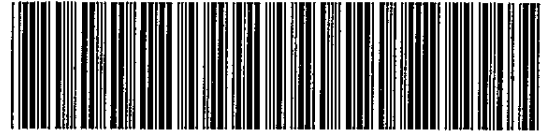

**ARTICLE ONE**



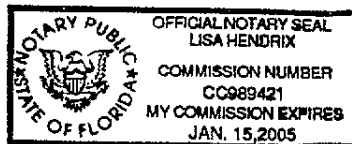
