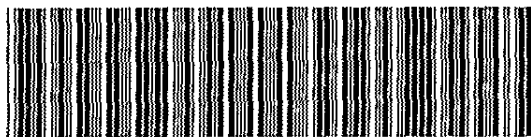

ARTICLES OF INCORPORATION

ARTICLE I NAME

The name of this corporation is - FINE EUROPEAN CRAFTSMANSHIP, INC.

ARTICLE II DURATION

This corporation shall have perpetual existence commencing on the date of the filing of these Articles with the Department of State.

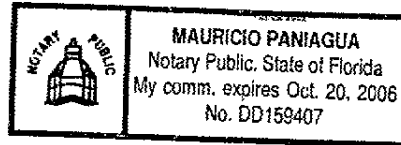
