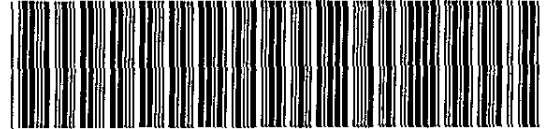

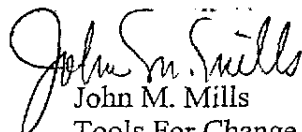

**ARTICLES OF AMENDMENT  
TO THE ARTICLES OF INCORPORATION OF  
THE FIRST NEW MILLENNIUM REAL MAINTENANCE & WORK CENTER, INC.**

Pursuant to the provisions of Chapter 607.1006 et seq. of the Florida Statutes, the undersigned corporation hereby adopts the following Articles of Amendment to its Articles of Incorporation:

1. The name of the corporation is **THE FIRST NEW MILLENNIUM REAL MAINTENANCE & WORK CENTER, INC.**
2. The following amendment to the Articles of Incorporation was adopted by the Board of Directors of the corporation on April 15, 2004, in the manner prescribed by the Florida business Corporation Act:

**ARTICLE I: NAME OF THE CORPORATION** is hereby amended to indicate that **THE FIRST NEW MILLENNIUM REAL PROPERTY MAINTENANCE & WORK CENTER, INC.** is the name of the corporation effective immediately.

3. The shareholders are not required to vote on the amendment to the Articles of Incorporation.
