ARTICLE I NAME

This corporation shall exist perpetually.

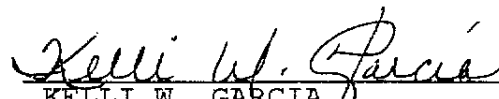
ARTICLE X LIMITATION OF LIABILITY

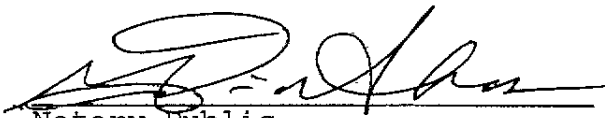
