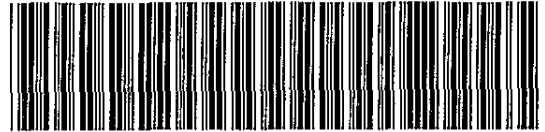




ARTICLE VIII


