ARTICLES OF INCORPORATION
OF
NPR ENTERPRISES, INC.

The undersigned for the purpose of forming a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I

Name

The name of the corporation is and its address is NPR Enterprises, Inc. 1335 NW 21 Terrace, Bay 3, Miami, Florida 33142.

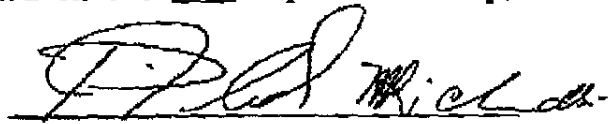
