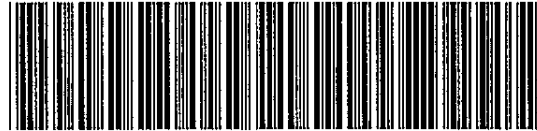



The aggregate number of shares which the corporation shall have authority to issue is one hundred (100) of \$1.00 par value.


ARTICLE FIVE


The Board of Directors is empowered to make, alter or repeal the Bylaws of the corporation without restriction of their powers conferred by statute.
