ARTICLE ONE

DURATION

2.1 The term of existence of the Corporation is perpetual.

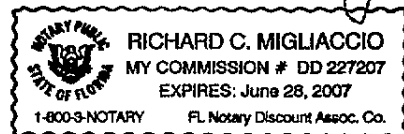
