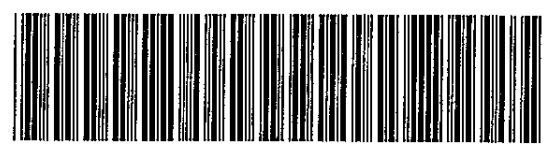

**ARTICLE I - NAME**

**ARTICLE II - DURATION**
