**ARTICLES OF INCORPORATION  
OF**

**R.L. LEVITT MD, P.A.**

The undersigned, for purposes of forming a professional corporation under the provisions of §607, the Florida Business Corporation Act, and §621, the Professional Service Corporation Act, adopts the following Articles of Incorporation.

**ARTICLE I**

The name of the corporation is R.L. LEVITT MD, P.A., (the "Corporation").

**ARTICLE II**

The address of the principal office and the mailing address of the Corporation is 445 Grand Bay Drive, Apt. #06, Key Biscayne, Florida 33149.

**ARTICLE III**

The general purpose for which the corporation is organized is to engage in every aspect of the practice of medicine. The professional services involved in the corporation's practice of medicine may be rendered only through its officers, agents and employees who are duly authorized and licensed to practice medicine in the State of Florida.

The corporation shall not engage in any business other than the practice of medicine. However, the corporation may invest its funds in real estate, mortgages, stocks, bonds and other types of investments, and may own real and personal property necessary for the rendering of the professional services authorized hereby.

**ARTICLE IV**

This Corporation shall have authority to issue One Hundred (100) shares of Common Capital Stock having a par value of \$0.01 per share.

**ARTICLE V**

The Corporation shall hold a special meeting of shareholders only:

- (1) On call of the Board of Directors or persons authorized to do so by the Corporation's Bylaws; or
- (2) If the holders of not less than 50 percent of all votes entitled to be cast on any issue proposed to be considered at the proposed special meeting sign, date, and deliver to the Corporation's secretary one or more written demands for the meeting describing the purpose or purposes for which it is to be held.

**ARTICLE IV**

The street address of the Corporation's initial registered office is 445 Grand Bay Drive, Apt. 806, County of Miami-Dade, State of Florida 33149 and the name of its initial registered agent at such office is Richard Levitt.

**ARTICLE VII**

The Board of Directors of the Corporation shall consist of at least one director, with the exact number to be fixed from time to time in the manner provided in the Corporation's Bylaws. The number of directors constituting the initial Board of Directors is one (1), and the name and address of the member of the initial Board of Directors, who is to serve as the Corporation's director until successors are duly elected and qualified is:

**ARTICLE VIII**

This Corporation shall indemnify and shall advance expenses on behalf of its officers and directors to the fullest extent not prohibited by law in existence either now or hereafter.
