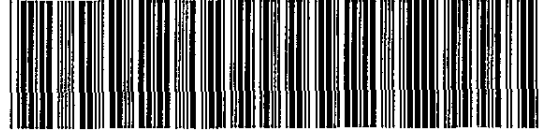

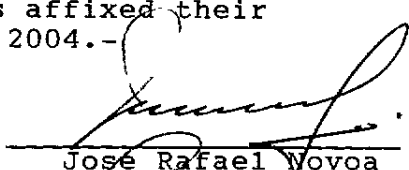
ARTICLE X - RESTRICTIONS ON TRANSFER OF STOCKS

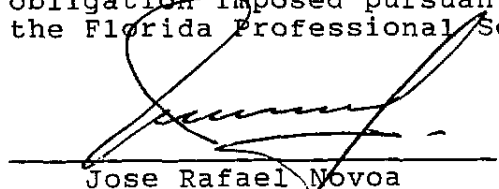

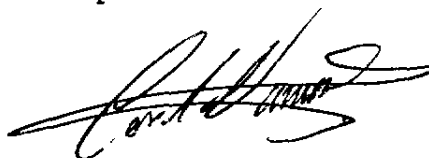
