**ARTICLES OF INCORPORATION
OF
ALVARADO INSPECTION SERVICES, INC.**

ARTICLE I - NAME

The name of this corporation is **ALVARADO INSPECTION SERVICES, INC.**

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles of Incorporation with the Department of State.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business related to real estate inspection services.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue 100 shares of one Dollar (\$1.00) par value common stock which shall be designated as "Common Shares".




