**ARTICLES OF INCORPORATION  
OF  
V2, INCORPORATED**

The undersigned, acting as Incorporator of a corporation under the Florida Corporation Act, adopts the following Articles of Incorporation for such corporation:

**ARTICLE I  
NAME**

The name of the corporation is V2, INCORPORATED.

**ARTICLE II  
DURATION**

The period of its duration is perpetual. Corporate existence shall commence on the date and time of the filing of these Articles of Incorporation by the Department of State.

**ARTICLE III  
PURPOSE**

The purpose of this corporation is to engage in any activities or business permitted under the laws of the United States and the State of Florida.

**ARTICLE IV  
ADDRESS**

The initial post office address of the principal office of the corporation in the State of Florida is:

Edgewater, Florida 32132

The Board of Directors from time to time may move the principal office to any other address in Florida.

**ARTICLE V  
CAPITAL STOCK**

The corporation is authorized to issue one hundred (100) shares, all of one class, at \$1.00 par value.

**ARTICLE VI  
INITIAL REGISTERED OFFICE AND AGENT**

**ARTICLE VII  
INITIAL BOARD OF DIRECTORS**

**ARTICLE IX  
DIRECTORS' AUTHORITY TO FIX COMPENSATION**

Directors shall have the authority to fix the compensation of the officers of the corporation.

## **ARTICLE X PREEMPTIVE RIGHTS**

Each shareholder of this corporation shall have the first right to purchase shares (securities convertible into shares) of any class, kind, or series of stock in this corporation that may from time to time be issued (whether or not presently authorized), including shares from the treasury of this corporation, in the ratio that the number of shares they hold at the time of issue bears to the total number of shares outstanding, exclusive of treasury shares. This right shall be deemed waived by any shareholder who does not exercise it and pay for the shares preempted within thirty (30) days of receipt of a notice in writing from the corporation, stating the prices, terms and conditions of the issue of shares, and inviting him to exercise his preemptive rights. This right may also be waived by affirmative written waiver submitted by the shareholder to the corporation within thirty (30) days of receipt of notice from the corporation.

## **ARTICLE XI INDEMNIFICATION**

The corporation may be empowered to indemnify any officer or director, or any former officer or director in the manner set out and provided for in the by-laws of this corporation.

## **ARTICLE XII AMENDMENT OF ARTICLES**

The power to adopt, amend, or repeal the Articles of Incorporation of this corporation shall be vested in the Board of Directors by a majority vote.

## **ARTICLE XIII SHAREHOLDERS QUORUM AND VOTING**

A majority of the shares entitled to vote, represented in person or by proxy, shall constitute a quorum at a meeting of shareholders. If a quorum is present, the affirmative vote of a majority of the shares represented at the meeting and entitled to vote on the subject matter shall be the act of the shareholders.

## **ARTICLE XIV REMOVAL OF DIRECTORS**

At a meeting of shareholders called expressly for that purpose, any one director, or the entire board of directors, may be removed, with or without cause, by a vote of the holders of a majority of the shares then entitled to vote at an election of directors.

**ARTICLE XV  
INFORMAL ACTION OF DIRECTORS**

If all the directors severally or collectively consent in writing to any action taken or to be taken by the corporation, and the writings evidencing their consent are filed with the Secretary of the Corporation, the action shall be as valid as though it had been authorized at a meeting of the Board of Directors.

**ARTICLE XVI  
AMENDMENT OF ARTICLES**

This corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation or any amendment hereto and any right conferred upon the shareholders is subject to this reservation.
