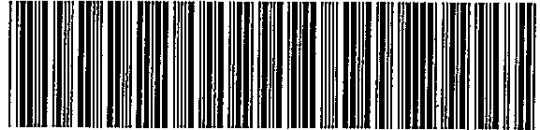

The name of the Corporation is: SubTerra Contracting, Inc.

Article II - Duration :

The Corporation has perpetual existence commencing on the date of execution and acknowledgment of these Articles.

Article III - Purpose :

This Corporation is organized for the purpose of ownership in investments, real estate, installation and maintenance of underground utilities. This Corporation shall also provide project and site management and may transact any or all other lawful business.
