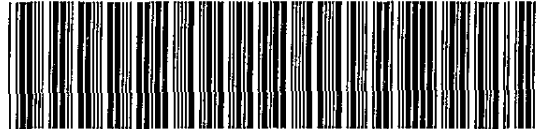

The undersigned subscribers to these articles of Incorporation, each a natural person competent to contract, hereby associate themselves together to form a corporation under the Laws of the State of Florida.

Articles I

The name of this corporation is: BRET International, Inc.

ARTICLE II

The general nature of the business or businesses to be transacted by this corporation is the following, namely:

- (a) To own operate a service business, provide international service of goods, provide consumer services, retail store, consignment store, or any store or store front serving the consuming public. To engage generally in the business or ownership and operation of retail store, consignment store or any store or storefront serving the consuming public for profit.
- (b) To acquire all real property and equipment necessary to conduct such business or businesses and to do every thing commonly done by those conducting a similar business.
- (c) To borrow money for the business of the corporation, and for any and all purposes and obligations upon such terms as the Board of Directors may determine.
- (d) To enter into, make, perform, and carry out contracts of every sort and kind with any person, firm, association or corporation private, public or municipal, or body politic, and with the Government of the United States or any state, territory or colony thereof, or any foreign government.
- (e) To do everything necessary, proper, convenient or incidental to the accomplishment of the purposes and objectives of the corporation, or which is calculated directly or indirectly to promote the interest of the corporation or to enhance the value of its properties or rights.

ARTICLE III

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is ONE HUNDRED (150) SHARES of common stock without nominal or par value. The consideration to be paid for each share shall be fixed by the Board of Directors.

ARTICLE IV

The amount of capital with which this corporation will begin business is not less than ONE HUNDRED (\$150.00) DOLLARS.

ARTICLE V

This corporation is to exist perpetually.

ARTICLE VI

The initial street address of the principal of this corporation in the State of Florida is 791 Vista Meadows Drive, Weston, FL 33327. The Board of Directors may from time to time move the principle office to any other address in Florida.

ARTICLE VII

The corporation shall have not less than one (1) Directors initially. The number of directors may be increased or diminished from time to time, by By-Laws adopted by the stockholders, but shall never be less than one.
