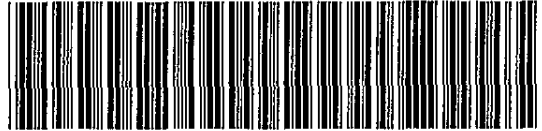

ARTICLE I

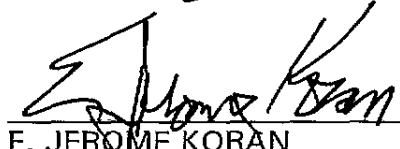

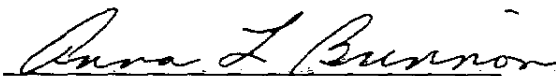

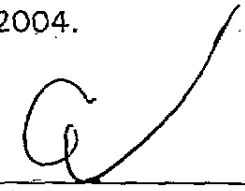
