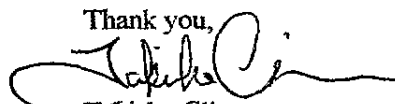

The corporation 's shall be existence perpetually.

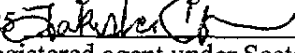
Article III – Purpose
