ARTICLE I-NAME

The name of this corporation is C HOMES REALTY & INVESTMENTS,  
INC.

ARTICLE II-DURATION

The corporation shall have a perpetual existence.

ARTICLE III-PURPOSE



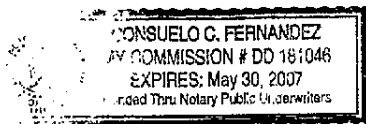


