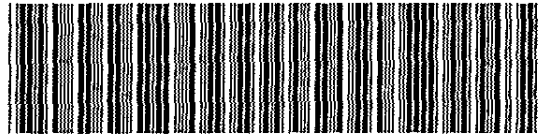

NAME

The name of the corporation is Tailwind Aviation of Central Florida, Inc.




