ARTICLES OF INCORPORATION OF FRED RAYNER AIR CONDITIONING OF SARASOTA, INC.

ARTICLE 1. - NAME

The name of this corporation is **FRED RAYNER AIR CONDITIONING OF SARASOTA, INC.**
