

**ARTICLES OF INCORPORATION
OF
FRED RAYNER AIR CONDITIONING OF SARASOTA, INC.**

ARTICLE 1. - NAME

The name of this corporation is **FRED RAYNER AIR CONDITIONING OF SARASOTA, INC.**

ARTICLE 2. - DURATION

This corporation shall exist perpetually unless dissolved according to Florida law.

ARTICLE 3. - PURPOSE

This corporation is organized for the purpose of transacting any and all lawful business.

ARTICLE 4. - POWERS

This corporation shall have all of the powers enumerated in the Florida General Corporation Act.

ARTICLE 5. - CAPITAL STOCK

This corporation is authorized to issue 7,500 shares of voting common stock with a par value of \$1.00 per share.



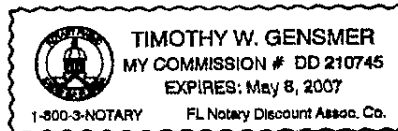
