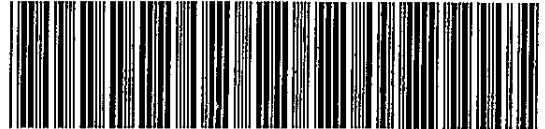

The undersigned TAMAS S. KIS does hereby make, subscribe, acknowledge and file these Articles of Incorporation for the purpose of becoming a corporation under the Laws of the State of Florida.

ARTICLE I
CORPORATE NAME

The name of the corporation shall be:

ARTICLE II
NATURE OF BUSINESS

The general nature of the business to be transacted is engaging in the operation of a computer technologies business serving business and consumer clients in the State of Florida.

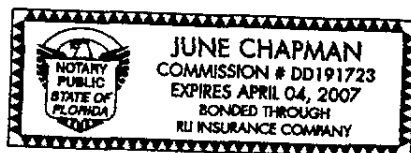

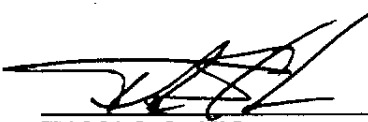
