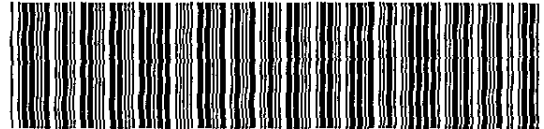

ARTICLE I -- NAME

The name of this corporation is: R.C.G. Trucking Line, Inc.

The power to adopt, alter, amend or repeal by-laws shall be vested in the shareholders.

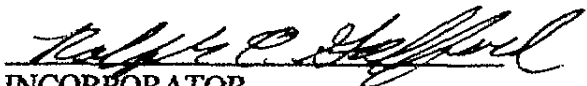
ARTICLE XII – INDEMNIFICATION

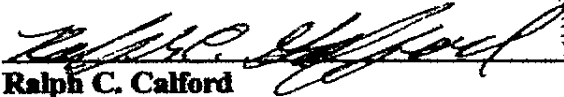

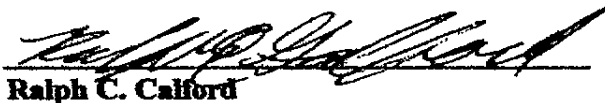
