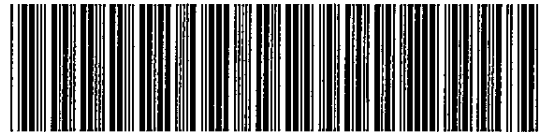

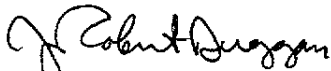

ARTICLE I. NAME

NAME: The name of this corporation is POLITICAL RESEARCH, INC.

ARTICLE II. DURATION

This corporation shall have perpetual existence, commencing on the 15th
day of April, 2004.

ARTICLE III. PURPOSE

This corporation is organized for the purpose of forming an organization which measures public opinion and from that develops a political message to utilize in communication to the public, and transacting any and all other lawful business in the State of Florida and the United States of America.

ARTICLE IV. CAPITAL STOCK

This corporation is authorized to issue 7,500 shares of (\$1.00) par value common stock.

ARTICLE V. PREEMPTIVE RIGHTS

Every shareholder, upon the sale for cash of any new stock of this corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his pro rata share (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

ARTICLE VI. INITIAL REGISTERED OFFICE AND AGENT

The street address of the initial registered office and initial principal office of this corporation is 1008 Sierra Blanca Court, Lady Lake, Florida 32159 and the name of the initial registered agent of this corporation at that address is JOHN J. 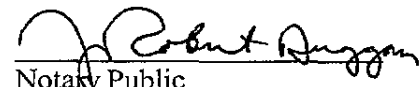
