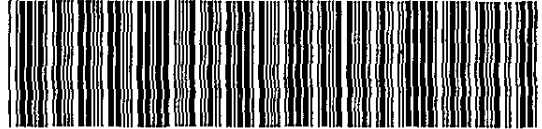



Article I - Name

The name of this corporation is SKYLINE AVIATION, INC.

Article II - Duration

The term for which this corporation shall exist shall be perpetual and its existence shall begin on the date of execution and acknowledgment of these Articles.

Article III - Purpose

This corporation is organized for the purpose of transacting any or all lawful business.

Article IV - Capital Stock

The maximum number of shares that this Corporation is authorized to have outstanding at any time is 1000 shares of common stock having a par value of \$1.00 per share.


